
Corporation is using in-house developed online application from 1996-97 to carryout different operations. The online application covers the operational functions of the Corporation. Hitherto, this application was maintained by the in-house team and has carried out two up-gradations successfully. As the previous upgradation is more than 12 years, Corporation decided to upgrade the online application using the latest technology. Accordingly, the upgradation work is entrusted to Centre for Smart Governance, a Society formed by the Govt.of Karnataka under e-Governance(DPAR). The Centre for Smart Governance has taken up the up-gradation project and work is under way.

As the existing application used in the Corporation is being upgraded to the latest available technology, it was thought of developing a web enabled application and incorporate facilities like online application for loan, payment gateway etc.

In order to have a user friendly online application covering all the working aspects and requirements of the Corporation, it is decided to have a User Application Testing Team comprising mix & match of experienced officers of the Corporation. The responsibility of these officers is to review the new application being developed, do the testing parallely with the existing application and give inputs for effective development of new application.

The list of User Application Testing Team is enclosed to this ION.
