OFFICE ORDER

The tenure of some of the retired officers who were engaged as Consultants in the Corporation, in the critical areas namely Technical and Legal, has expired recently. To carry out the day to day operations of the Corporation without hindrance, it is felt necessary to engage the services of the earlier Consultants for a period of one month i.e., an alternative arrangements are made or until the ongoing selection process of new recruitment gets conclude.

However, as the Model Code of Conduct (MCC) is in force, it may take some more time to put in place the services of the Consultants or conclude the process of recruitment. In order to tide over the situation and in the administrative exigency, the services of the following retired officers who were working as Consultants on contract earlier is engaged for a period of one month w.e.f. 20.05.2024 on a monthly consolidated remuneration of Rs.83,000/- (Rupees Eight Three Thousand only).

This is purely temporary contractual engagement for the tenure stated above. The consultants engaged are required to report to the concerned Branch Managers (HQ branches) and discharge the assigned functions in accordance with the norms prevailing in the Corporation / guidelines / manuals issued from time to time. The Branch Managers are directed to permit the above consultants to discharge the operational functions in the relevant field for the stipulated tenure. The functions discharged by the Consultants shall be under the supervision of the BMs/ GMs/ competent higher authorities.
