It is reported that the legal consultant who was discharging the legal functions of BO Belagavi and BO Vijayapura is met with an accident and unable to attend to the office work. Similarly, the Legal officer who was looking after the legal functions of BO Hassan and BO Chikmagaluru has retired on 30.04.2024. In view of prevailing Model Code of Conduct (MCC) guidelines, it will take some more time to make suitable alternative arrangements to discharge the legal functions in the above branches.

In the light of the above, and in the administrative exigency, the branch office Belgavi, BO Hassan and BO Chikmagaluru are permitted to utilise the services of Legal Counsels empanelled to the Branch Office as detailed in the circular referred above.
