




The scheme for extending reliefs and concessions for closure of loan accounts of Post MoU Doubtful cases was introduced in the Corporation vide circular No. 924 dated 26/05/2016, which was valid up to 31/12/2016. The scheme was extended up to 31/03/2020 vide Circular No.924(D) dated 12/07/2019.

A note was placed before the Board in its meeting held on 26/06/2020 for further extension of validity of the scheme. The Board approved the extension of validity of the scheme up to 31/03/2021. All other eligibility criteria, terms and conditions of the scheme laid down in the Circular No.924 dated 26.05.2016 and Circular No.924(C) dated 01/06/2018 remain unaltered.
