The special OTS Scheme for settlement of small loans upto Rs.10 lakhs was launched during July 2007. The matter was deliberated by the Board during October 2007 and a decision was taken to keep the scheme upon till 31.03.2008. For the FY 2008-09, the GoK has made a budgetary provision of Rs.50 crores under the scheme. Therefore, it has been decided to extend the validity of the said scheme by three months i.e., upto 30.06.2008.

The BMs are instructed to give maximum stress on the settlement of small cases under the scheme to enable us to draw the provisions made by the GoK. A review of the scheme will be taken up in the end of first quarter and branches will be advised once again.
