As you are aware, modification to debt reconstruction scheme (DRS) has been issued vide above referred circular. While extending benefits under this scheme, all the concerned are hereby instructed to collect audited financial statements for the previous financial year and provisional balance sheet upto date for the current financial year in respect of loans above Rs.25 lakh cases (cumulative sanctions of live accounts). Proper analysis of the financial statements shall be carried out. The units which do not have operating profits and have accumulated loss, should only be covered / extended the benefits under the scheme. Further, all DRS proposals shall be pre-audited before submission to the approving authority.
