This is in continuation of the above referred Circular and Inter Office Note. The Government has reviewed the Scheme of Interest Subsidy and issued revised guidelines under Government Order No.SWD 76 SLP 2008, Bangalore, dated 22.05.2010. The Government Order prescribes that an applicant should furnish an affidavit duly attested by a Notary affirming that he/she shall be liable for prosecution as well as to pay back the entire interest subsidy availed, in case the Caste Certificate submitted by the applicant is found to be false at a later date.

Under the above referred ION dated 22.03.2010, a draft of affidavit to be obtained had been circulated. Necessary changes have been made to the said draft of the affidavit including the condition now prescribed by the Government.

All the concerned are advised to obtain an affidavit in the revised format enclosed to this Circular.

(format of Affidavit to be taken in respect of loan proposals under the special Interest Subsidy Scheme of GoK for SC/ST entrepreneurs)

Karnataka State Financial Corporation is considering my loan application under the Special Interest Subsidy Scheme of Government of Karnataka for Scheduled Caste / Scheduled Tribe entrepreneurs wherein the applicant would be entitled for interest subsidy.

One of the prerequisites of the scheme as prescribed by the Government of Karnataka for availing interest subsidy is that a person should not have availed any interest subsidy under any other scheme of the Central Government or State Government earlier. Also I am aware that the said benefit of interest subsidy can be availed only once.

I affirm and state that I / our firm / our company have so far not availed any interest subsidy under any of the schemes either from the Central Government or State Government. The present application made by me / us is the first application whereunder I / unit will be claiming interest subsidy.

In the event it is later ascertained that the above statements are not true, I / unit will be disentitled for any interest subsidy for the loan sanctioned by Karnataka State Financial



Corporation under the interest subsidy scheme of the Government of Karnataka for SC/ST entrepreneurs vide GO No. SWD 76 SLP 2008 Bangalore, dated 22.05.2010 for SC/ST entrepreneurs.

I affirm and state that whatever I have stated above is true and that based on my statements made above GoK is extending interest subsidy to me / my firm / company. In the event of the Caste Certificate furnished by me is found to be false at a later date I shall be liable for prosecution and also liable to pay back the entire interest subsidy availed by me under the scheme.
