Sub : Digital Signature Certificate (DSC) for CERSAI.

In order to conduct eAuction, all the BMs/HODs have been provided with DSC issued by Centre for eGovernance during 2013-14. Further, the BMs / HODs were advised to use the same DSC for the purposes of CERSAI vide ION No. 3167 dtd 11.11.2014. Recently, some of the BMs / HODs have informed that the validity of the DSCs issued by Centre for eGovernance is expired and they are not able use these DSCs in CERSAI site. In this regard the Centre for eGovernance was contacted for renewal of the expired DSCs. They informed that the expired DSCs will not be renewed, but, can be continued to use for eAuction process. These DSCs cannot be used for any other purpose like CERSAI / MCA / Income Tax etc as the validity stands expired.

In this regard, as one more DSC is required for working on CERSAI site, the BMs / HODs are requested to purchase Class-II DSC with 2 years validity from any private vendor for CERSAI purpose. Further, it is observed that, only the Tokens of either Aladdin or Moser Baer brand will work on CERSAI Website and the brand ePass 2003 will not work as the same is not compatible with CERSAI Website. In view of this, while purchasing the DSC, the BMs / HODs should ensure that **either Aladdin or Moser Baer Token** is provided by the vendor. For any clarification / assistance, Sri.
