CIRCULAR No.918(A)

Sub: Withdrawal of Circular No.5(2)/4/2-15-MSME Pol. dated 29.09.2015 of DC(MSME) on "Clubbing of Investment" of different enterprises under the same ownership.

Ref: Our circular No.918 dated 17.11.2015.

Based on the SIDBI's Circular FI No.08/2015-16 dated 26.10.2015 and letter No.5(2)/4/2015-MSME Pol. dated 29.09.2015 issued by DC(MSME), the above referred circular No.918 dated 17.11.2015 was issued clarifying that investments on plant and machinery / equipment of all enterprises under same ownership shall be clubbed together while assessing the status of MSMEs as per provisions under the MSMED Act, 2006.

Now, SIDBI vide its Circular FI No.10/2015-16 dated 16.03.2016 has informed that DC(MSME) vide its letter dated 03.03.2016 has withdrawn its earlier letter No.5(2)/4/2015-MSME Pol. Dated 29.09.2015. The matter has been placed before the board its meeting held on 29.03.2016. In view of this, the circular no.918 dated 17.11.2015 may be treated as withdrawn.
