**Sub : On-line entry of Special One Time Settlement Scheme of GoK
for small loans up to Rs.10.00 lakhs.**

Ref : Circular No.921 dated 14-01-2016.

With reference to the above, modified Special One Time Settlement Scheme of GoK was introduced vide Circular referred above. Further, vide ION dated 15-04-2016 issued by ED-I, it was clarified that validity of the said Scheme is continued and eligible accounts can be covered under the scheme. The Branch Offices were required to make on-line entry of the accounts processed under this Scheme and take prior concurrence of the Controller Department before issue of Account Closure letters.

However, it is observed that subsequent to the reintroduction of the Scheme, on-line entry of the cases covered are not being followed. Hence, it is hereby instructed that all the Branch Offices to enter the data of the cases already covered in the on-line system, subsequent to reintroduction of the Scheme and send compliance report to Controller Department. Further, fresh cases should be entered in the on-line system and ensure clearance from Controller Department before issue of Account Closure letter.
