Sub : Interest Subsidy Scheme for Women Entrepreneurs.

Ref : Circular No.920 dated 14-01-2016.

The Interest subsidy Scheme for Women Entrepreneurs was introduced vide Circular No.920 dated 14-01-2016. KSWDC is the co-ordinating agency on behalf of State Government for the Scheme and the funds are released from KSWDC. The Corporation is implementing the Scheme as per the guidelines issued. KSWDC has so far released Rs.163.67 lakhs, out of which Rs.108.54 lakhs has been disbursed to the loanes. KSWDC has informed that they will be able to release another Rs.94.67 lakhs towards General category Women Entrepreneurs to meet the Interest subsidy commitment. The Corporation has already sanctioned Rs.85.00 crore up to December, 2016, under the Scheme.

In view of the budget constraints expressed by KSWDC, Branches are instructed not to entertain any fresh proposals under General Category under this Scheme, for the current year except the one which are already approved by the District Level Committee. The proposals from SC/ST Women Entrepreneurs may be accepted, as the funds are available under this category. The above is for strict compliance.
