Sub: Assistance to Ground Mounted Solar Projects.

Ref: 1 Circular No.912 dated 28-05-2015

Ref: 2 Circular No.912 (A) dated 30-11-2016

A detailed Status Report on the implementation of ground mounted solar power projects was placed before the Executive Committee Meeting held on 10-01-2017. The subject was discussed in the EC. The Committee observed that the tariff of Rs.8.40 / unit would be applicable only for such projects which are commissioned within the scheduled time (31st December 2016).

It was also observed that while some of the projects have been implemented but they are not commissioned within the stipulated date, there are also some cases where the projects are not implemented and the legal documents also have not been signed. After deliberations, the following decisions were taken:-

- (a) In respect of the cases where the project implementation is complete but not commissioned within the scheduled date of 31st December 2016, further disbursements should be made only after ensuring that they are entitled for tariff of Rs.8.40 / unit.*
- (b) In respect of the cases where the projects are not implemented fully and loan documents have not been signed, sanction of loans may be cancelled immediately. In case proof is given to the effect that they are entitled for tariff of Rs.8.40 / unit, the loans may be revived.*

The contents of this circular shall be brought to the notice of all the concerned in your office / department.
