(Court Cases)

On review of pending Court cases, it is noticed that online Legal MIS information is not being updated regularly. Statistics furnished by the concerned Departments and the Branch Offices does not tally with the online Legal MIS information. In this regard all the Heads of Departments / Branches should ensure that the concerned Legal Officers update all the relevant information in the On-line system. A compliance report along with the reports generated through online Legal MIS system should be sent within 15 days from the date of this ION. Non-compliance will be viewed seriously and Administration Department will be asked to take disciplinary action against the erring officers.

Further it is noticed that the Corporation has obtained decrees in several PG cases. However, Execution Petitions are not being filed. This lapse has been observed by Audit Department. Therefore, all concerned are advised to review decree cases and to file Execution Petitions immediately, without any loss of time. If for some reasons Execution Petitions are not filed reasons to be indicated. The Legal Officers / Recovery Officers and Branch Managers will be held responsible for having not filed the Execution Petitions. Further, the General Managers are to review the cases where decree is obtained and Execution Petitions are filed / not filed during their visit to the Branch Offices.
