Sub: Sanction of term loans under Interest Subsidy Scheme for Women Entrepreneurs.

Ref: ION No. KSFC/HO/MD/DGM[C]/ C 7495/2017-18 dt. 06-01-2018.

The maximum loan eligibility amount under Interest Subsidy Scheme for Women Entrepreneurs was enhanced from Rs.50.00 lakhs to Rs.200.00 lakhs vide G.O. No. ಮಮಇ 50 ಮಅನಿ 2017, ದಿನಾಂಕ: 12-05-2017. For the FY 2017-18, total sanctions of Rs.200.00 crore was fixed, which was distributed branch-wise. However, in view of slow sanctions up to December, 2017, ION dated 06-01-2018 was issued advising Branch Offices to sanction term loans to all eligible beneficiaries under the Scheme up to 31-03-2018, without relating to the sanction limit fixed earlier.

Some Branch Offices have expressed doubts whether the Scheme is continuing for the FY 2018-19 and whether fresh sanctions can be made under the Scheme. It is hereby clarified that restriction of sanctions up to 31-03-2018 was applicable to the sub-limit of branches to sanction the loans under the Scheme for the FY 2017-18. The Scheme is continuing and the Branch Offices are advised to sanction to eligible cases as per the prevailing guidelines. The sub-limit for each Branch will be issued after completion of the budget exercise for the FY 2018-19.
