



Subject : Information for Annual Accounts.

The information for finalisation of Annual Accounts for the FY 2020-21 relating to the liabilities arising on account of Court Cases, Consumer Forum Cases, Statutory liabilities etc. will have to be quantified and wherever necessary provision has to be made. In cases where liabilities are not quantified or the appeals are pending, proper disclosure has to be made under the head "Contingent liability". To make assessment of such liabilities, the following information is required :

1. Cases decreed against the Corporation where payments are not yet made;
2. Cases pending before Consumer Courts (District, State and National level) where orders have been passed ;
3. Cases where sale has been set aside and orders passed for refund of sale consideration with or without interest ;
4. Claims by Statutory Authorities like PF, ESI, Central Excise etc., where demands have been made for payment out of sale consideration of secured assets ;
5. Claims from Commercial Taxes, Road Transport Authorities etc. against the secured assets.

The information relating to such cases may be furnished as per format enclosed to DGM [C], Head Office, on or before 07th May, 2021 positively.
