Corporation has taken up 'Implementation of Integrated Software Solution for KSFC' where in current On Line Applications are getting migrated to Web Enabled Application. In this regard obtaining Unit PAN, PAN of Promoter/Guarantor is mandatory.

It is observed that the PAN for Units is not being captured at present. Also, the PAN for Promoter/Guarantor is not available for all the records. In this regard, it is envisaged to verify the available PAN and correct the same if required and enter PAN wherever the same is not available.

The IT Department has made provision to capture PAN of Live Units under the option

Also Promoter/Guarantor PAN may be entered/updated under the option
