## **INTER OFFICE NOTE**

### **SUB: GUIDELINES ON WOMEN ENTREPRENEUR SCHEME**

Government of Karnataka has provided a sanction budget of Rs.200.00 crore for sanction under Interest Subsidy Scheme for Women Entrepreneurs Scheme. In view of large number of application / enquiries under the Women Entrepreneurs Scheme, the following guidelines may be adopted so that maximum number of women entrepreneurs can be given benefit under the scheme while processing the loan application under the Scheme until further orders.

- ❖ To extend the entire eligible loan amount under Interest Subsidy Scheme where the eligible loan amount is up to Rs. 50.00 lakhs.
- ❖ Where the eligible loan amount exceeds Rs.50.00 lakhs but is less than Rs.100.00 lakhs, the loan of Rs.50.00 lakhs may be provided under Interest Subsidy Scheme and the balance amount under General Scheme with normal rate of interest.
- ❖ Where the eligible loan amount is Rs.100.00 lakhs and above, 50% of the eligible loan amount may be extended under Interest Subsidy Scheme and the balance 50% under General Scheme with normal rate of interest. However, the maximum loan under interest subsidy scheme shall not exceed Rs.200.00 lakhs.

Branches are instructed to ensure that the sanction of loan with interest subsidy component is well within the limit allocated to each branch.

Further, there was a stipulation in the Government order that prior approval of the Government should be obtained before sanction of loans under Women Entrepreneurs Scheme. A request was made to the Government for waiver of this condition. The Branch Managers are instructed to proceed with sanction of the loan once the proposal is cleared at the District Level Committee as per earlier guidelines.
