**Sub : Interest subsidy scheme for First Generation Entrepreneurs.**  
**Ref : Letter No. KSFC/HO/ED-I/2017-18/C 3524 dated 22-09-2017.**

The Interest Subsidy Scheme for First Generation Entrepreneurs establishing new micro and small industries who avail term loans from KSFC has been introduced by GoK vide its order bearing No.CI 89 CSE 2014 dated 10-03-2015. The eligibility criteria for coverage under the scheme was limited to total project cost of Rs. 100.00 lakhs. Subsequently, GoK has enhanced the project cost limit to Rs.500.00 lakhs vide G.O. dated 21-09-2017. The same has already been intimated to all the Branch Offices vide letter under reference.

It is brought to the notice of all the Branch Offices that sufficient funds are available under this scheme for utilization. All the Branch Offices are advised to give wide publicity about the revised eligibility and cover more number of cases under this scheme. Further, the Branch Offices are advised to expedite the disbursement under the scheme, so that more interest income is earned during the current Financial Year.
