Sub : Confirmation of loan balance from the borrowers.

As you are aware vide above referred Circulars, the system of obtaining Acknowledgement of Debt [AoD]/Balance Confirmation Certificate [BCC] from the borrowers were put in place. Further, the BMs/HODs were instructed to personally supervise and ensure that BCCs AND AoDs are obtained every year [as on 31st March] from all the borrowers, before the end of June of subsequent financial year.

In this regard, the BMs/HODs are once again advised to ensure that BCCs/AoDs are obtained before 30-12-2017 as per the format enclosed, if the same is not yet obtained for the FY ended 31-03-2017. In case the borrowers fail to submit the same, further recovery action be initiated by issuing SCN and thereafter recalling the loan for non-compliance.

The Internal Audit Department is advised to monitor the compliance of the above and report non-compliance, if any, in the Audit Reports and submit the same to the MD.
