

INTER OFFICE NOTE

Sub: Acceptance of property of Remco (BHEL) Housing Co-operative Society Ltd as security.

It is informed by the BO Kolar that one M/s. All Bricks and Blocks, Plot No. 220, 3rd Phase, KIADB Indl. Area, Malur, Kolar District has approached the BO Kolar for financial assistance for establishing a brick manufacturing unit. The said firm has offered the collateral security property standing in the name of one Nagarathna Aradhya situated at No. 364, New CMC Kh.No. 1341479/364 of Sy No. 2/3, 52/11, 2/2, 52/6, 25/4 (25) REMCO (BHEL) House Building Co-operative Society Ltd at Pattanagere Village, Kengeri Hobli, Bangalore South taluk.

On close scrutiny of the documents furnished by the firm and by physical inspection by the BO, the BO Kolar has noticed that the land acquired by the said Society has already been quashed by the Hon'ble Supreme Court of India vide SLP No. 12535-37/91 and further Smt. Nagarathna Aradhya has filed a suit vide OS No. 4612/2006 for permanent injunction before the Hon'ble City Civil Court which was dismissed by the Hon'ble court. Suppressing all these facts they had proposed to offer the said property as collateral security. Therefore it is advised to the Branches to be careful in respect of property situated at REMCO Layout if offered as security.
