Sub: Interest subsidy scheme for first generation entrepreneurs.
Ref: (1) Circular No. 913 dt.1.6.2015
(2) Circular No. 913 (A) dt.22.9.2017

The Government of Karnataka has introduced interest subsidy scheme for micro and small enterprises to be set up by first generation entrepreneurs vide GO No.CI 89 CSC 2014 dt.10.3.2015. The project cost limit is enhanced from Rs.100.00 lakhs to Rs.500.00 lakhs vide Corrigendum No.CI 289 CSC 2015 dt.21.9.2017 issued by C & I department.

A clarification was sought from the Director of Industries and Commerce whether industrial warehouses coming up in Industrial Areas are eligible for interest subsidy under the scheme. It is clarified by the office of the Directorate of Industries and Commerce vide their letter No.ಕೈಲ/ಇ1/88/ಕೆ.ಎನ್.ಎಫ್.ಸಿ/ಬಡ್ಡಿನಹಾಯಧನ / 2017-18 dt.13.12.2017 that the industrial warehouses setup in the Industrial Areas are eligible for interest subsidy under Interest subsidy scheme for First Generation Entrepreneurs.

Branches are advised to take note of the above clarification issued by the Directorate of Industries and Commerce and cover the eligible cases under the Interest subsidy scheme for the First Generation Entrepreneurs.
