**INTER OFFICE NOTE**

**Sub: Sanction of term loans under Interest Subsidy Scheme  
For Women Entrepreneurs.  
Ref: Circular No. 927 dated 05-08-2017.**

The maximum loan eligibility amount was enhanced from Rs.50.00 lakhs to Rs.200.00 lakhs under Interest Subsidy Scheme for Women Entrepreneurs vide G.O.No. ಮಮಇ 50 ಮಲನಿ 2017, ದಿನಾಂಕ: 12-05-2017. In anticipation of large number of enquiries it was decided to temporarily put a limit of Rs.200.00 crores of corporate sanction for the FY 2017-18, considering the budgetary support under the Scheme. The Branch-wise maximum loan limit to be sanctioned was enclosed to the Circular referred above.

On review of performance as at the end of December, 2017, it is observed that out of Rs.200.00 crore fixed, Rs.118.00 crore has been sanctioned. It is also observed that some Branches have utilised the maximum limit fixed, whereas progress in respect of other branch offices is slow. This is creating disparity, wherein there are proposals pending in some Branch offices, which are not being entertained, in view of the limit fixed, while, In other Branches the limit given remain unutilized. In order to correct this disparity, and to ensure that all eligible cases are covered, it is decided to dispense with the limit of sanction in the Circular No.927 dated 05-08-2017. Branches are advised to sanction loan to all eligible beneficiaries under the Scheme up to 31-03-2018, without relating to the sanction limit fixed earlier.
