In continuation of creation of Credit Processing Centers (CPC), the teams consisting of Technical, Legal Officers have been formed. The team members to discharge their duties and responsibilities as detailed in the Inter Office Note referred above. The broader guidelines & administrative control, roles and responsibilities, files management etc., of these CPCs are already indicated in the referred ION. The CPC teams are obligated to perform their duties as per prescribed norms specified in lending policies & also as per Circulars & Inter Office Notes issued from time to time. The main objectives behind formation of CPCs are, to :

- Ensure efficient delivery of credit with focused attention of asset growth and quality credit delivery system.
- Establish dedicated and expert team for speedy credit appraisal, inspection and disbursement system with the available manpower.
- Strengthen the collective and efficient working methods to improve credit delivery at local level.
- Explore new channels of credit delivery for the benefit of MSMEs.

The respective Branch Managers of CPCs shall provide and ensure the required infrastructure, manpower, logistics support for effective functioning of CPC teams.

The respective General Managers of the Circles shall supervise, monitor, co-ordinate for the effective functioning of the Credit Processing Centers (CPCs) in their jurisdiction. The respective Executive Directors will have administrative control.
