The Board of Directors in their meeting held on 15.02.2022 have accorded approval for promotion of Sri Hariswamy, Manager(F&A) to the post of Assistant General Manager with effect from 01.12.2021 i.e., from the date when his juniors are promoted. Therefore, in accordance with the approval of the Board Sri Hariswamy, Manager(F&A), has been promoted to the post of Assistant General Manager with effect from 01.12.2021 in the pay scale of Rs. 82000 - 1900 - 83900 - 2200 - 97100 - 2500 - 112100 - 2800 - 117700. As per the KSFC Staff Regulations he will be on probation for a period of one year. He will continue to work in the Personnel & Administration Department.
