Sub: Downgrading the post of Gen.Manager as Dy.Gen.Manager.
-o0o-

There are 05 sanctioned posts of Gen.Manager in the Corporation and at present all the 05 posts are vacant. Two DGMs who are confirmed in the cadre of DGM have been placed in-charge of Gen. Managers and these two are retiring in the month of July and August 2023. Hence, these two officers will continue as GM I/c till their superannuation.

As per the KSFC C&R Rules 2022 minimum service of 02 years in the cadre of DGM is mandatory to be eligible for the post of GM. As per the available data of DGMs, only one officer will become eligible for GM in March 2025. Thus, there is no scope to fill up the vacant posts of GMs in the Corporation in the near future. Therefore, to meet the immediate operational requirements in the Corporation it has been decided to operate the posts of GMs in the downgraded posts of DGMs.

Accordingly, the DGMs who are placed to head the Circles (C-I, C-II, C-III & C-IV) and HO Internal Audit are delegated to exercise the operational, administrative and financial powers of GMs. The powers of GMs delegated to DGMs will be co-terminus with the tenure of DGMs as heads of Circles

This comes in to force with immediate effect, until further orders.
